Your application and documentation will be delivered to the Embassy and your case will be processed by the Embassy as soon as possible.

Please note that your application is **incomplete**. The document(s) highlighted below are missing. The Embassy therefore kindly requests you hand in the below documentation. **ALL documents must be submitted in colour:**

	Application form completely filled on https://applyvisa.um.dk/ , printed and signed by the applicant
	Visa Fee payment receipt printed from https://applyvisa.um.dk/
	One recent (less than six months old) passport-size photograph in color with white background and good resemblance. (3.5cm / 4.5cm). Photoshopped pictures are forbidden and application will become inadmissible if a photoshopped picture is handed in.
	<ul style="list-style-type: none"> - The Passport should be valid for at least three months (any other type of travel document should be valid for at least six months), beyond the intended duration of stay in the Schengen territory and with at least two blank page to affix the visa. - Temporary or Permanent Residence permit in Mexico (validity of at least 3 months after departure from Schengen Area). Exceptions apply.
	Overseas travel medical insurance valid for all Schengen-countries. The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure.
	Flight reservations of return, or round ticket. If applicant is traveling to several Schengen states proof of intra-Schengen Flight reservations, Train Itinerary or Car rental.
	Proof of Relationship <ul style="list-style-type: none"> • In case of visiting spouse living in Denmark - Copy of Marriage Certificate, if applicant is married and cannot provide evidence of marital status in the passport. • Certificate proving existence of family relationship, if applicant is visiting close relatives
	Invitation from Host. The embassy recommends that the host fill in a VU2 invitation form. This form can be found on https://nyidanmark.dk/en-GB/You-want-to-apply/Short-stay-visa/Invitation-of-a-visa-applicant . Invitation ID is sufficient if the host is Danish or lives in Denmark. A paper invitation is only mandatory in representation cases (Norway, Sweden or Iceland). 	Proof of accommodation. Hotel reservations, rental of holiday home or campus residence reservation. If you intend to stay with a family member or a friend, proof of sponsorship and/or private accommodation from the host. If you are travelling to several Schengen states, proof of accommodation in each of them.
	In case of minors (< 18 years) travelling: <ul style="list-style-type: none"> • If the minor is traveling with only one parent, written consent certified by public notary of the other parent or guardian, except in cases of a parent having sole custody or guardianship of the minor. • If the minor travels alone (without parents), written consent, certified by public notary, from both parents or guardians having custody or guardianship of the minor. • A photocopy of both parents' passports. If not applicable, copy of birth certificate of applicant and copies of the ID cards of the parents
	Evidence of source of Financial support: <ul style="list-style-type: none"> • Original personal bank statement showing movements in the last three months, duly stamped and signed by the bank; As a general rule, you must have at your disposal approx. DKK 350 per day. A smaller amount may be accepted if you are staying in a private home and your host will cover all costs. If you are staying at a hotel, the amount must be greater, approx. DKK 500 per day. If the applicant is employed: <ul style="list-style-type: none"> • Pay slips for the last three months; • Employment contract AND holiday approval/leave letter from employer If the applicant is a company owner or self-employed: <ul style="list-style-type: none"> • Certificate of registration of the company. If the applicant is sponsored: <ul style="list-style-type: none"> • Proof of sponsorship If the applicant is retired: <ul style="list-style-type: none"> • Pension statements for the last three months; • Proof of regular income generated by ownership of property or business
