⁴⁾ No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents - or one of these - were born Danish or have subsequently obtained Danish nationality.

⁵⁾ Where several documents are issued at the same time, a total fee of DKK 190 shall be charged.

⁶⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 190 shall be charged per statement.

⁷⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,890 shall be charged for the first passport and DKK 950 for subsequent passports.

⁸⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 5,185 shall be charged for the first passport and DKK 950 for subsequent passports.
