	One recent (less than six months old) passport-size <b>photograph</b> in color with white background and good resemblance. (3.5cm / 4.5cm). Photoshopped pictures are forbidden and the application will become inadmissible if a photoshopped picture is handed in.
	The <b>Passport</b> should be valid for at least three months (any other type of travel document should be valid for at least six months), beyond the intended duration of stay in the Schengen territory and with at least two blank page to affix the visa.
	A covering letter from the Indian organization/school containing:
	<ul> <li>Name and date of birth of the applicant.</li> <li>An outline of the applicant's itinerary, purpose of visit, how/why the trip is relevant to his/her current studies, and the period of intended stay in Denmark/Schengen.</li> </ul>
	Copy of student cards or certificates of the organization/school/establishment
	An <b>Invitation, entry ticket or enroliment confirmation</b> fromorganization/school containing; name of the invited applicant, purpose of visit, dates of the intended stay, nature of costs being covered by host (boarding & lodging). <u>Preferably</u> a VU3 form signed with NEM-ID which can be found on <u>www.newtodenmark.dk</u>
	Overseas <b>travel medical insurance</b> valid for all Schengen-countries. The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure.
	Flight reservations of return or round ticket. If applicant is traveling to several Schengen states proof of intra-Schengen Flight reservation, Train Itinerary or Car rental.
	<b>Proof of accommodation</b> : Hotel reservations, rental of holiday home or campus residence reservation. If you intend to stay with a family member or a friend, proof of sponsorship and/or private accommodation from the host. If you are travelling to several Schengen states, proof of accommodation in each of them.
	in case of minors (< 18 years) traveling:
	<ul> <li>If the minor is traveling with only one parent, written consent certified by public notary of the other parent or guardian, except in cases of a parent having sole custody or guardianship of the minor.</li> </ul>
	<ul> <li>If the minor travels alone (without parents), written consent, certified by public notary, from both parents or guardians having custody or gaurdianship of the minor.</li> </ul>
	<ul> <li>A photocopy of both parents' passports. If not applicable, copy of birth certificate of applicant and, copies of the ID cards of the parents</li> </ul>


